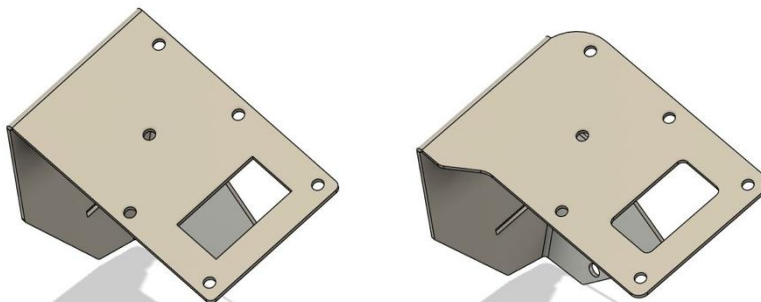

2026 RH Lidar Holster Mount Update

This technical bulletin must be read carefully and thoroughly **before** initiating an exchange. FMS Solutions, LLC accepts no liability for issues arising from failure to follow the instructions or recommendations below.

Old mounts look like the ones below.



Old mount - holster behind mount point.

New mount - holster ahead of mounting point

Complaint: Riders reported that the early Lidar gun holster mounts for 2026 R 1300 RT-P models may alter the path of hot air from the radiator exhaust, causing rider discomfort.

Solution: After extensive testing, a redesigned holster mount was developed for the R 1300 RT-P which moves the holster forward to eliminate disruption of radiator heat exhaust.

Field Solution: Replace early version Lidar gun holster mounts with the new mount. This will eliminate the air deflection, though heat is still exhausted from the radiator.

Note: Radiator output air runs hotter in high-heat conditions, since there's less cool ambient air to dilute it. FMS always recommends wearing proper riding gear regardless of mount version.

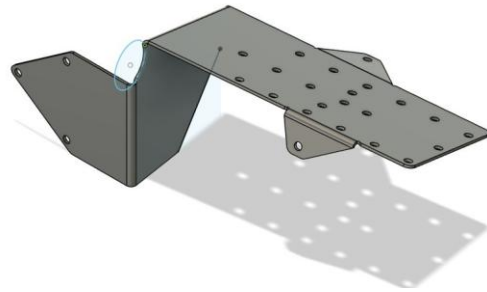
Product development and improvement is an ongoing activity at FMS. We listen to customer feedback and value the depth of experience of our motor officer customers.

The mounting bracket in question was developed prior to the onset of summer heat, so having now experienced a full season of rider feedback, we felt that a change in the design was warranted. We wish to thank AZ DPS for assisting with testing in high temperature conditions earlier this year.

As a gesture of goodwill, FMS will exchange original version mountings for the new design with agencies that wish to obtain the new design. The new mount will be sent to the agency at no charge after receipt of their exchange mounts. Return shipment of the old exchange mounts is at the expense of the sender. FMS will replace mounts received with the new design Lidar mount and pay to ship them to the requesting agency.

New Zebra / TTB Mount

Note: Early Zebra printer mounting brackets attached to the Lidar mounting bracket. A new bracket will be needed that will work with all combinations or stand alone. That new bracket shown above is in production now with availability in early September. The new Zebra mount will be available for purchase once in stock.

- Order this exchange through the [website](#) to reserve your place in the queue. Select the quantity of mounts you're exchanging, a payment of \$0.01 is required at check-out (sorry, website won't process \$0.00 orders), and your order confirmation serves as your exchange reservation. Enter Coupon Code "ExchangeProgram" to negate the \$10.00 minimum handling fee. Ensure the information provided in the order is where you want the exchanged mounts to be delivered to.
- This exchange mount must be ordered separately with no other products in the order. Orders combining this exchange with other items will be voided, and store credit will be issued instead. The product has a limit of 10 per order. If more are needed, place a second order.
- Do not send your mounts yet. Wait for our email confirmation that your mounts are reserved before shipping anything back, this keeps turnaround as efficient as possible for everyone.
- Remove the Lidar / radar holster from the mount prior to sending the mount(s) for exchange.
- **Keep all mounting hardware**, as the same hardware will be used when you receive the new mounting bracket.
- Once you receive our confirmation, return the mounts you wish to exchange to: FMS Solutions LLC, 566 Falcon Fork Way, Saint Johns, Florida 32259
- All new mounts will be sent via ground shipping, so ensure the address is deliverable.

LED lights from Fenix, Inc., Code 3, Inc. and Littlite are covered for 5 years by their manufacturer's respective warranties – processed through FMS Solutions, LLC.

This warranty extends only to the FMS accessory and does not include: damage caused by accidents or abuse; incorrect installation; labor to diagnose, remove, repair or replace; any consequential damage or loss of use. Any FMS Accessory suspected of being defective should be returned to FMS Solutions, LLC along with a copy of proof of purchase and warranty request form available on the FMS website. FMS Solutions, LLC will determine if the FMS accessory has a warrantable defect, and if so, will repair or replace the item and return it to the sender without charge. The decision to repair or replace said item is solely the prerogative of FMS Solutions, LLC.
